If our student is accepted:

1. We as parent(s) or guardian(s) accept God's responsibility which says, "Train up a child in the way he should go and when he is old, he will not depart from it"(Proverbs 22:6), do affirm that this training is carried on in the home. We promise that the home will provide a secure haven of safety, free from the very influences we recognize as harmful.
2. We have carefully examined and agree with the Christian purpose and Statement of Faith of Aletheia Christian Academy and desire the Academy to work with us in the total education of our children.
3. In full cooperation with the Academy, we will regularly attend the Parent-Teacher Fellowship meetings and other functions requiring our participation.
4. We agree to assume the responsibility for my student's education by supervising assigned homework and keeping in regular contact with my student's teachers.
5. We pledge our loyalty to the aims and ideals of Aletheia Christian Academy and will bring criticisms directly to the administration so that they may be properly dealt with by those in authority.
6. The teachers and administration are given full discretion in the discipline of our children, within the guidelines stated in the Parent/Student Handbook.
7. We pledge that if for any reason our child does not meet the academic requirements or cooperate with the disciplinary standards of Aletheia Christian Academy, we will withdraw him without delay and will cooperate with the administration to make the withdrawal as quietly as possible, avoiding discussion with those not involved, so as to avert a spirit of dissension and division at either our child's expense or the school's. Aletheia reserves the right to dismiss, suspend, or otherwise discipline any student who does not adhere to the standards stated in the Parent/Student Handbook.
8. Students are accepted on a trial basis for the first grading period. Any student may be asked to withdraw at any time if he/she does not strive for academic excellence.
9. We agree to make timely payments of our financial obligations to Aletheia Christian Academy.
10. We understand that Aletheia Christian Academy is a non-profit ministry operating on the principle of faith. Tuition is kept as low as possible to make Christian education available to those who desire it for their children. *Tuition and fees do not cover all operating costs. Additional funds and needs must be met with gifts and personal services of our parents.* We ask that each parent purpose to give, as regularly as God provides, to meet financial needs; to perform services when needed; and to uphold Aletheia Christian Academy consistently in family prayer.
11. A.C.A. admits students of any race, color, national and ethnic origin to all rights, privileges, programs and activities made available to students of the school.
12. We also understand that this application cannot be considered without the registration fee and that, if the student is accepted, the registration fee will not be refunded if we later decide to withdraw our student.

We understand this to mean that this Family Commitment is also a binding financial obligation. Should a change during the year become necessary, tuition will be pro-rated on a monthly basis. While tuition is pro-rated on a monthly basis for students entering or leaving during the year, all fees are payable in full when a student first enters school and are non-refundable.
